Learned senior counsel would state that these demand drafts would cover the claim of the respondent company in the petition filed before the National Company Law Tribunal, Hyderabad Bench at Nagole, Ranga Reddy District.

As the petitioner is able to prove its *bonafides* apart from its financial liquidity as on date, there shall be interim suspension as prayed for.

Sri Avinash Desai, learned counsel, shall deposit the aforesaid demand drafts with the Registrar (Judicial) of this Court before the end of today under acknowledgment.
